- ➤ Ed Finance T. Sloan
- > Equity and Social Justice A. Mardli & A. Bergmann
- > Ariel attended the ESJ Spring Seminar in February.
  - o Key note: Dr. Shannon Moore: Teaching About Controversial Topics in Schools
    - Education is political. Everything is political.
    - Public space vs. private space values ("those are your private values, in this room/public space you cannot say it in that way")
    - She provided criteria to decipher topics that are either open, controversial, or noncontroversial issues
    - Ex) would having the discussion lend legitimacy to an unfounded position? Will inviting debate cause harm? Are both positions supported by evidence? Have experts already determined that the issue is closed? Contrary views are held, but do they stand up to reason? Do viewpoints infringe on public values?
  - Career Trek presentation
  - Regional meeting next meeting May 2 in person, at the Elm Creek Golf Course, Ariel and Andre would both like to attend.
  - ESJ Topics that matter right now sessions
  - Supporting LGBTQIA youth in a climate of hate
  - Bill 35 updates and questions
    - Public registry questions: What is MTS fighting for? Just having employees names and if they are active or inactive

- Roster Panel: Who will be on it? Not determined yet.
- How will complaints be handled?
- What are the possible consequences that could be decided on by the panel?
- Likely going to be similar to Sask.'s model
- PX Committee proposed changes to how standing committees and local chair seminars work (in 2025-2026).
- Addressing equity, diversity, and inclusion through Provincial bargaining: Took the best of the best of all collective agreements as their starting package
  - Change of language to be more inclusive (they/them vs. he/him, she/her)
  - Changed to people-first language ('students with exceptional needs', not 'exceptional students')
  - Bereavement leave inclusion of spouse, children, parent, sibling, grandparents natural, in-law, step, or foster (vs. mother, father, son, daughter, spouse)
  - Maternity/parental leave issues
  - PTSD has a Return-to-Work clause that they're still bargaining (after you leave you must return to work after 10 months or pay back top-up)
  - Issues around Increment Dates (if you go on leave Sept. 5th you should be paid what you would have been paid Sept. 1 not what you ended on in June)
  - The Employers side wants to claw back the 90% for parents taking an extended parental leave because it requires them to pay more than those taking 12 months
- Resources for staff (ex. using inclusive language in the classroom, articles about controversial topics in the classroom): what's the best way for us as ESJ chairs to share this information with staff?

- ➤ Indigenous Education D. Wilson
  - Demaris attended the Indigenous Chair Winter Seminar. There was a last-minute change in presenters, meaning that the Anti-Indigenous Anti-Racism Document that we have been developing is currently on hold. The focus was on **Decolonizing the**Classroom and MMIWG2S. Time was spent brainstorming with MTS Officials about how MTS can support members with fulfilling the Calls for Justice for the *National Inquiry into Missing and Murdered Indigenous Women & Girls.* \*\*Copied below for reference. Requests were made for PD opportunities (potentially with police/RCMP) for Trauma Training & Identifying/Intervening with Grooming, as well as MTS premade lesson plans on MMIWG2S that would be accessible on the MTS website.
  - Update for Prints: Some schools have put up the Indigenous framed prints that we purchased last year, others have said they want a French translation included on the frame. It looks like it would be \$7 a frame to add the vinyl decals in French. We will cover the cost.
  - \*\*Calls for Educators:
    - 1. We call upon all elementary, secondary, and post-secondary institutions and education authorities to educate and provide awareness to the public about missing and murdered Indigenous women, girls, and 2SLGBTQQIA people, and about the issues and root causes of violence they experience. All curriculum development and programming should be done in partnership with Indigenous Peoples, especially Indigenous women, girls, and 2SLGBTQQIA people. Such education and awareness must include historical and current truths about the genocide against Indigenous Peoples through state laws, policies, and colonial practices. It should include, but not be limited to, teaching Indigenous history, law, and practices from Indigenous perspectives and the use of *Their Voices Will Guide Us* with children and youth.
